State Council of Higher Education, Hyderabad is requested to instruct the Convenor,Ed.CET-2002 ,Andhra University ,Visakapatnam to allot the candidates as per the orders issued in the reference 1st read above. He is further requested to instruct the Scholar's College of Education, Wanaparthu Revenue Division, Mahaboobnagar District to implement the methodology-wise percentage in 15% quota allotted to the said management strictly without deviation.



In terms of the guidelines issued by the Government in the reference 2nd read above, and in pursuance of the N.C.T.E. Act No.73 of 1993, the State Level Standing committee constituted by the Government, has scrutinized the application made by the Secretary & Correspondent, Scholar's Education Society, Wanaparthu, MahboobNagar District for issue of No Objection Certificate to obtain recognition from the Southern Regional Committee, National Council for Teacher Education, Bangalore to open a College of Education as per the norms and standards prescribed by the National Council for teacher Education. 

NO OBJECTION CERTIFICATE

This is to certify that the Government of Andhra Pradesh accords "No Objection" to Secretary & Correspondent, Scholar's Education Society, Wanaparthi, Mahboob Nagar District to apply for permission/recognition to start B.Ed. College in **Wanaparthi, Revenue Division in Mahboobnagar** District in accordance with the National Council for Teacher Education Act and the rules/regulations made there under, subject to the following conditions.

1. The College of Education shall be started only after obtaining recognition from Southern Regional Committee, National Council for Teacher Education, Bangalore. The Commissioner & Director of School Education, Andhra Pradesh, Hyderabad is empowered to take steps to prosecute the Institution in accordance with Law/ and to cancel the "No Objection Certificate", in case the Society starts/opens the College of Education without necessary permission/recognition accorded by the National Council for Teacher Education or for any deviation of rules and regulations prescribed under the National Council for Teacher Education Act. The candidates who prosecute their studies in the College of Education established by the above Society without necessary permission/recognition of the competent authority will not be permitted to appear for the University examinations.
2. The allotment of candidates to B.Ed. course shall be made by the Convenor, Ed. CET, year after year.
3. The intake capacity of the College shall be 120 (ONE HUNDRED AND TWENTY ONLY)
4. Penal action shall be taken against the Society, if the college functions unauthorisedly, under the relevant provisions of Andhra Pradesh Education Act I of 1982.
5. This "No Objection Certificate" is valid for the academic year 2002- 2003.
6. This "No Objection Certificate" is issued pursuant to the Judgement dated 19.6.2001 of the Honourable High Court in W.A.No.626/2000.
