## <u>ORDER</u>

WHEREAS, Sri Venkateswara Educational Society, Cuddapah District, Andhra Pradesh had submitted an application in the name and style of Scholars College of Education, Pochigutta (Nandi Hills), Wanaparthy – 509103, Mahabubnagar District, Andhra Pradesh for seeking grant of recognition for B.Ed course on 31.12.2001.

AND WHEREAS, the SRC after considering the report of the visiting team as well as other relevant materials, granted recognition to the institution for offering B.Ed course with an intake of 100 students from the session 2002-2003 on condition to shift the institution to permanent premises vide order no. F.AP/NEW/B.ED/257/SRO/NCTE/2002-2003/6722 dated 04.04.2003.

While going through the records submitted by the institution, it is found that:

The institution was not shifted to permanent premises as per norms and standards and conditions mentioned in recognition order dated 03.07.2003 Not Communicated the shifting of premises to the SRC and not paid the prescribed fees for shifting of premises.

**AND WHEREAS,** the matter was considered by SRC in its  $178^{th}$  Meeting held on  $13^{th} - 14^{th}$  July 2009 and decided to issue show causes notice Under Section 17 of NCTE Act and obtain the following documents.

- Demand Draft of Rs. 40000/- towards inspection fee in favor of "The Member Secretary, NCTE" payable at Bangalore should be submitted.
- 2) Land documents of the new building / location for having own land in the name of the institution / Society / Trust.
- 3) Building plan of the new building duly approved by the government authority.
- 4) Building completion Certificate form the Government authorities in the prescribed format (Format enclosed).
- 5) Land Usage Certificate from the concerned Government authorities stating that the land is exclusively permitted / sanctioned for Educational Purposes only should be submitted.
- 6) Encumbrance certificate from the competent Government should be submitted.
- 7) Fixed Deposit Receipt of Rs. 5 lakhs kept in <u>JOINT ACCOUNT</u> with SRC in Nationnalised Bank for a period of 5 years towards Endowment fund in <u>ORIGINAL</u> should be submitted.
- 8) Fixed Deposit Receipt of Rs. 3 lakhs kept in <u>JOINT ACCOUNT</u> with SRC in Nationnalised Bank for a period of 5 years towards Reserve fund in <u>ORIGINAL</u> should be submitted.
- 9) Certificate of Registration / Bye-law of the Society / Trust should be submitted.
- 10) The affidavit in Rs. 100/- stamp paper in the prescribed format with Notary attestation should be submitted.

Accordingly, notice was issued to the institution on 28.08.2009.

**AND WHEREAS,** the applicant institution had submitted its written representation dated 16.09.2009 to SRC, NCTE along with the D.D of Rs. 40000/-. The inspection of the institution was conducted on 09.02.2011 and the VT report was received to SRC on 17.02.2011.

**AND WHEREAS**, the SRC in its 208<sup>th</sup> Meeting held on 13-14<sup>th</sup> of July 2011 considered the VT report & VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act for the following:

- 1) As per building completion certificate, the built up area is 15,618 sq.ft. which is inadequate as per NCTE norms.
- 2) Education Technology lab, other lab/Physical Education needs to be strengthened.
- 3) Bye-Laws of the Society are to be submitted by the management and etc.
- 4) Consolidated salary is being paid to the staff members.

Accordingly, a show cause notice was issued to the institution on 06.08.2011 and the institution has submitted its written representation on 10.10.2011.

**AND WHEREAS,** the SRC in its 215<sup>th</sup> meeting held on 12-13<sup>th</sup> December, 2011 considered the reply of the institution dt. 10.10.2011, VT report, and all the relevant documentary evidences and its was decided to issue show cause notice.

- In the building completion certificate submitted, location of land and village name is not mentioned.
- 2) The institution has submitted 21 bills towards purchase of computer accessories and sports equipment, only 6 bills are dated after inspection; remaining bills are old bills, which are related to bills before inspection.
- 3) Bank statement is not legible towards the salary paid to the staff members.
- 4) Staff details are not submitted.
- 5) Up-to date encumbrance certificate is not submitted.

Accordingly, show cause notice was issued to the institution on 10.02.012 and the institution had submitted its written representation on 13.04.2012.

**AND WHEREAS**, the SRC in its 233rd Meeting held on 26th – 28th September, 2012, considered the reply of the institution vide letter dt. 13.04.2012 and all the relevant documentary evidences and it was decided to serve Final Show cause Notice under NCTE Act, for the following:

- Notarized English version of the certified copy registered land documents not submitted.
- As per encumbrance certificate submitted, the land is in individual name, which is not permissible as per NCTE Regulations 2009. The land should be in favour of Society/institution.
- 3) The institution has not submitted the staff approval from affiliating body/University.

Accordingly, a final show cause notice was issued to the institution on 01.11.2012 and the institution had submitted its written representation dt. 19.11.2012 received in the office of SRC on 19.11.2012.

**AND WHEREAS**, the SRC in its 240th meeting held on 9-11th March, 2013 considered the reply of the institution vide letter dt. 19.11.2012 and all the relevant documentary evidences and it was decided to serve Final Show cause Notice under NCTE Act, for the following:

- 1) The institution has not appointed Part time Lecturer in Fine Arts and Physical Education.
- 2) The institution has not submitted approved staff list with all details, duly approved by the University/affiliating body.
- 3) Fresh Up-to-date encumbrance certificate issued by sub-registrar is not submitted.

Accordingly, a final show cause notice was issued to the institution on 27.04.2013. The institution has submitted its written representation on 20.05.2013.

**AND WHEREAS**, the SRC in its 246<sup>th</sup> Meeting held on 02th – 04<sup>th</sup> June, 2013 considered the written reply of the institution vide letter dt. 20.05.2013 and other related documents along with the original file of the institution for shifting to new/permanent premises, and decided to permit shifting to new premises under intimation to the University.

AND THEREFORE, the institution is permitted to shift to new premises at Scholars College of Education, Nagavaram X Road, Wanaparthy, Mahabubnagar District, Andhra Pradesh – 509103 for conducting B.Ed course.

Also ordered that, a copy of this order be published in the official Gazette.
